

**PERMISSION TO HUNT**

FARMER, \_\_\_\_\_, has agreed in writing to permit GEORGIA HOG CONTROL to lawfully hunt hogs and predators on farmer's property briefly described as and located in \_\_\_\_\_ County/Countries, GA. In consideration of this permission, GEORGIA HOG CONTROL has agreed to enter into the following indemnification and release:

GEORGIA HOG CONTROL acknowledges and understands that no warranty, either express or implied, is made by the FARMER as to the condition of the property being leased. GEORGIA HOG CONTROL acknowledges that dangerous and unknown conditions, risks, and hazards do exist on the property being leased, and that hunting on rural property such as the property being leased can result in injury or property damage to the person/persons involved in these activities, to third-party bystanders, and to the FARMER and/or his or her property. The many possibilities and sources of injury or damage are acknowledged by GEORGIA HOG CONTROL, and he/she comes on the leased property with full knowledge that hazards and risks exist. Accordingly, GEORGIA HOG CONTROL assumes all risks whatsoever to his or herself and property associated with the use of, or presence on, FARMER's property, including but not limited to GEORGIA HOG CONTROL'S presence in the vicinity of any buildings, machinery and equipment, above or below-ground utilities, roads, paths, ditches, bridges, berms, land indentions, trees, plants, fences, watercourses, wildlife, livestock, etc. GEORGIA HOG CONTROL hereby waives any and all rights to bring legal action against the FARMER, his or her successors or assigns, with respect to personal injury, death, or property injury of any type associated with the presence of GEORGIA HOG CONTROL on FARMER's property for hog removal.

Further, GEORGIA HOG CONTROL agrees to release, protect, defend, indemnify, and hold FARMER harmless from any and all liability, loss, damage, personal injury (including death), claims, demands, costs whatsoever, and causes of action of every kind and character, without limit and without regard to the cause or causes thereof or the negligence of any party or parties arising in connection herewith to any person or any property by act or omission of either the GEORGIA HOG CONTROL, or any employees, invitees, or guests of GEORGIA HOG CONTROL, whether authorized or unauthorized by FARMER to be present on the premises.
